IFRA standard categories by product type

Category 1	Products applied to the lips. / Toys
Category 2	Products applied to the axillae. (Body spray)
Category 3	Products applied to the face/body using finger tips. (eye products, make-up, make-up remover, pore strips, wipes, masks)
Category 4	Products related to fine fragrance. (EDT, scented bracelets, fragrances)
Category 5.A	Body lotion products applied to the face/body using hands (palms), primarily leave-on. (lotions, creams, products for feet, insect repellents, powders excluding those for children)
Category 5.B	Face moisturizer products applied to the face/body using hands (palms), primarily leave-on.
Category 5.C	Hand cream products, primarily leave-on. Nail care products and hand sanitizers.
Category 5.D	Children products, Oils, creams, lotions, powders and talc.
Category 6	Products with oral and lip exposure. (toothpastes, mouthwashes, sprays)
Category 7.A	Rinse-off hair permanent or other hair chemical treatments (e.g. relaxers), excluding hair dyes.
Category 7.B	Products applied to the hair with some hand contact (including hair dyes and excluding other rinse off). Dyes, lacquers, dry shampoos, deo x hair.
Category 8	Products with significant ano-genital exposure. (intimate wipes, absorbents, toilet paper)
Category 9	Products with body and hand exposure, primarily rinse off. (Soap, shampoo, detergents, shaving creams, depilatories, pet cleaners)
Category 10.A	Household care products excluding aerosols. Laundry detergent, washing machine, dishes, linen pretreatment, hard surfaces, dry cleaning, toilet wipes, room deo (no candles) potpourri, water for ironing.
Category 10.B	Household aerosol/spray products. For animals and insecticides.
Category 11.A	Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate - phototoxicity is unapplicable. (nappies, tampons)
Category 11.B	Products with intended skin contact but minimal transfer of fragrance to skin from inert substrate - phototoxicity is applicable. (Tights, socks, gloves, facial fabrics, napkins, solid fertilizers)
Category 12	Products not intended for skin contact, minimal or insignificant transfer to skin. (Candles, sticks, paints, plastics, laundry pods, automated deos, cat litter, paints, plastic items, scented packs, deo wc, shoe polishers)
